**IN 2016, 136 STUDENTS ENROLLED IN OUR CULINARY JOB SKILLS TRAINING PROGRAM. 100% OF OUR STUDENTS ARE LOW-INCOME; 83% WERE FEMALE; 32% LACKED A HIGH SCHOOL DIPLOMA OR GED; 26% REPORTED A FELONY CONVICTION; AND 44% HAD BEEN VICTIMS OF DOMESTIC VIOLENCE. AT THE TIME THEY ENTERED THE PROGRAM, 80% WERE EITHER ON TANF OR SNAP ASSISTANCE AND 20% WERE HOMELESS. THE ETHNIC BREAKDOWN OF OUR STUDENTS WAS 27% HISPANIC, 5% WERE NATIVE AMERICAN/ALASKAN, 2% ASIAN/PACIFIC AMERICAN, 19% CAUCASIAN, 17% WERE UNIDENTIFIED. THE AVERAGE AGE WAS 38.
